We are so excited to bring you our first newsletter from the Child Advocacy Center of Warren County (CACWC)- The Voice!



Over the last couple of years, we have added three powerful words to our materials: **Help. Hope. Heal.** We provide **help** by giving a child their voice to share their experience of abuse, neglect, or witnessing violence. **Hope** that a better future exists for kids who have experienced trauma. The ability to **heal** from their trauma through specialized services and support.

I am reminded almost daily why the services we provide are so important-- hearing a child say "I feel so much better" after sharing their story in the forensic interview, seeing a child come out of their shell because they truly feel safe and have completed counseling, or hearing about a child's bravery as they go through a trial that results in an offender being convicted.

The Child Advocacy Center (CAC) is a childfocused, community based facility in which representatives from many disciplines (law enforcement, child protection, prosecution, mental health, medical, and victim advocacy) work together to reduce the trauma victims experience with a confusing system.

- A welcoming, child-friendly facility where kids feel safe.
- A reduction in the number of interviews a child must undergo
- Specialized medical and mental health services to more effectively help the child
- Consistent and timely follow-up to child abuse reports
- Compassionate support and trauma informed
